## Schedule of Fees & Charges collected by Bank Zachodni WBK S.A. for banking services provided to Personal Customers

### CHAPTER I GENERAL PROVISIONS

1. Bank Zachodni WBK S.A., hereinafter referred to as BZ WBK, collects fees and charges for banking services provided to personal customers in line with this Schedule of Fees and Charges.

2. Definitions:

Partner outlet – BZWBK agency outlet operating under the name “Bank Zachodni WBK Partner”.

BZWBK Branch – BZWBK organisational unit conducting business operations.

BZWBK outlet – BZWBK Branch or BZWBK Partner outlet

Business Day – each day not being Saturday or a national holiday

3. Fees and charges are set in Polish zloty or in foreign currencies.

4. Collection of fees and charges.

#### 4.1. Bank accounts and savings accounts

Collection of fees and charges:

a) account maintenance – on the last day of the calendar month

b) transfers, statements, withdrawals – collective fees for individual transactions and statements sent from the first to the last day of a given calendar month are collected on a regular basis on the last day of a given calendar month excluding fx Konto24 account, Private Banking account, Wealth Management account in the case of which the fee is collected as follows: collective fees for individual transactions and statements sent from the first to the fifteenth day of a given calendar month inclusive and from the sixteenth to the last day of a given calendar month inclusive are collected on a regular basis on the fifteenth and the last day of a given calendar month

c) other fees are collected from the account – on the day of placing or effecting an order or on other dates indicated in this Schedule for individual fees and charges or in agreements signed by a customer and BZWBK.

#### 4.2. Debit cards/other electronic payment instruments and related activities

Fees and charges are collected:

a) on the day of effecting or settling a transaction or

b) in a monthly cycle – by the 10th day of each calendar month (inclusive); the only exception is a monthly fee for Visa KKS Lech card and Wydajesz & Zarabiasz card (issued by 16.02.2010) – fees are collected by the end of each calendar month.

c) in an annual/ semi-annual cycle – on the card issuance day or on 25<sup>th</sup> of each calendar month; the only exception is an annual fee for EURO<26 Maestro card – the fee is collected on the card issuance day.

#### 4.3. Electronic banking services

Sms-code and Alert24 Packages – fees are collected on the 5th day of a calendar month following the month they apply to.

#### 4.4. Credit cards

a) When the main card is issued, the Card account is debited with a card fee – during year one, within 3 months of the new card issuance.

b) thereafter, the card fee is collected on an annual or monthly basis, in accordance with the customer's instructions:

- the annual fee debits the card account on the day when the first list of transactions is generated, after the end of a month when the card account opening anniversary takes place,

- the annual fee debits the card account on the day when the first list of transactions is generated, after the end of a month when the card account opening anniversary takes place,

Thereafter, monthly fees are debited to the card account on the days when subsequent transaction statements are generated.

c) A fee for additional card is collected on the same date as the main card fee.

d) The main card holder has the right to change the cycle of card fee collection in the next years (from annual to monthly and otherwise). The above instruction will lead to changing the fee collection mode both for the main and the additional cards. The annual fee debits the card account on the day when the first list of transactions is generated, after the end of a calendar month when the card account opening anniversary takes place, Instructions to change the fee collection frequency should be reported by a customer not later than a week before the end of a month when the card account opening anniversary takes place.

e) When the MasterCard<30 is replaced at the renewal date for customers over 30 – a fee for card replacement is not collected.

#### 4.5. Insurance

a) Monthly fee for “Twoje Bezpieczeństwo” Package is accrued on the debt balance recorded on the 28th day of each month and then collected on the same date. When the date is a non-business day, the fee is collected on the last business day preceding that day.

b) Monthly fee for “Bezpieczne Pieniądze Komfort (Safe Money Comfort)” in the amount indicated in this Schedule of Fees and Charges is collected up-front for the following month on the last business day of a given month during the insurance validity period.

c) When funds in the bank account are insufficient to cover the fees collectable by the Bank as per Appendix 1, the insurance cover will be discontinued in accordance with Insurance terms & conditions.

d) Other fees are collected from the account – on the day of placing or effecting an order or at other dates indicated in this Schedule for individual fees and charges or in agreements signed by a customer and BZWBK.

- e) Hipoteka+ (Mortgage +) insurance:
  - for Życie 18+ (Life 18+) and Życie 48+ (Life 48+) packages, the fee is set based on the level of debt arising from a loan agreement used for determining the loan installment that falls due in a given settlement period
  - for Praca (Job) package, the fee is set based on the level of loan installment falling due in a given settlement period
5. Fees and charges for banking activities are not collected on:
  - a) operations related to repayment of debts toward BZWBK or its subsidiaries, regardless of the debt form (not applicable to operations effected from the Savings Account),
  - b) lodgements made by private individuals when an agreement signed with an account holder indicates that in this case, the fee is paid by receiver of the lodged funds,
  - c) cash lodgements made by BZWBK customer and related to payment of tax on civil law activities, provided the tax is on services provided by BZWBK.
6. Apart from the fees and charges listed in the Schedule, the following fees and charges are collected:
  - a) fees and charges collected by banks acting as agents, while effecting an order,
  - b) fees and charges for telecommunications and postal services for domestic and international transactions.
7. The applicable fees & charges are paid by the party that orders a transaction unless the parties to a given transaction agreed otherwise or the instruction submitted states otherwise and BZWBK accepts it. Fees & charges not paid by the other party within three months will be debited to the person who ordered a banking operation.
8. The fees & charges amounts will be rounded in line with generally acceptable principles.
9. For operations in foreign currencies, fees & charges will be calculated based on:
  - a) a PLN equivalent of the operation amount – in the case of fees & charges denominated in PLN,
  - b) operation amount - in the case of fees & charges and cost of international banks denominated in foreign currencies.Fees & charges denominated in PLN are converted at the average NBP rate applicable on the fee/ charge collection date, except for fees on operations related to:
  - management of f/x loans and guarantees (excluding early advice, indirect and confirmed guarantees) - converted at the fx buy/sell rate for foreign currencies applicable in BZ WBK,
  - purchase/sale of fx currencies at the BZWBK cash desks - converted at buy/sell rate applicable in BZWBK,
  - execution of collections and letters of credit in convertible currency - converted at buy/sell rate for foreign currencies applicable in BZWBK,
10. In the case of costs of foreign banks denominated in currency other than the currency in which they will be collected, the conversion is made at the average NBP rate applicable on the day of collecting costs, except for costs of operations related to the execution of collections and letters of credit in convertible currency, early advice, indirect and confirmed guarantees - converted at the sell rate for foreign currencies applicable in BZ WBK
11. Fees and charges for transfers/ cash lodgements to an account in another bank do not refer to funds transferred in a foreign currency to accounts of domestic banks and to transfers to accounts in foreign banks – fees and charges for the delivery of these transactions are collected in line with the fees for withdrawal orders.
12. BZ WBK will not notify its customers of changes in this Schedule of Fees and Charges which will consist solely in the introduction of new types of products or services to the BZ WBK offering and in the case of changes in products not referred to in agreements signed by the customer and the Bank.
